

The 53rd Annual Van Nationals, branded “Vanning to Mt. Olympus,” is a national gathering of custom vans and panel trucks scheduled for July 29 through August 2, 2026, at the Trumbull County Fairgrounds in Cortland, Ohio. Hosted by the Northeast Ohio Van Council, this long-running National Truck-In event brings together vanners from across the country for camping, a judged van show, games, live music, seminars, and on-site vendors in a festival-style atmosphere. Most vans are welcome regardless of condition, and the culture of the event emphasizes a friendly, inclusive community where participants and spectators can browse unique vehicles, shop with automotive and lifestyle vendors, and enjoy a full schedule of daytime activities and evening entertainment. The Trumbull County Fairgrounds provides large outdoor display areas, ample camping, and vehicle access, giving vendors strong visibility and steady foot traffic over the course of the show. Organized by volunteers and supported by national vanning organizations, the Van Nationals has been held annually since the 1970s and is recognized as the premier custom van event in the United States, making the 2026 edition a high-profile opportunity for brands to connect directly with a loyal enthusiast audience. - 3. Setup and Use of Space: Vendor may access the venue for setup from 7/26/26 to 8/2/26. Vendor will keep their area clean and comply with all venue rules, laws, and regulations.
- 4. Vendor Responsibilities: Vendor is solely responsible for: All required licenses, permits, and taxes for its operations. The safety and quality of its products/services.
- 5. Insurance and Liability: Vendor participates at its own risk and is encouraged to carry general liability insurance naming Organizer as an additional insured. Vendor agrees to indemnify and hold harmless Organizer, the venue, and their officers, employees, and agents from any claims, damages, or losses arising from Vendor’s acts or omissions.
- 6. Miscellaneous: This Agreement is governed by the laws of the State of Ohio. This document is the entire agreement between the parties regarding the Event and may only be modified in a signed writing by both parties.
